## SECTION 4 – FIRST-AID MEASURES

**Inhalation:** Remove victim to fresh air. If irritation persists call physician.

## SECTION 6 – ACCIDENTAL RELEASE MEASURES

**Protective Equipment:** Wear suitable respiratory protective equipment.

**Environmental Precautions:** Avoid runoff into storm sewers, ditches and waterways.  
**Methods for Cleaning Up:** Disposed contaminated material as waste according to Sec. 13. Ensure adequate ventilation.

## SECTION 7 – HANDLING AND STORAGE

### Handling
